



2. The name of the Trust shall be * GEETA CHARITABLE TRUST *

3. That objects for which Trust fund is established are medical relief, carrying out x-rays, ECG, ultrasound, clinical lab, various tests of blood, urine, stool, hypertension etc. education relief to the poor and advancement of any other charitable objects of general public utility not involving the carrying out of any activity for profit and for such purposes.

(a) To establish, maintain, and/or grant aid in cash and/or kind to hospitals, medical schools, medical colleges, nursing homes, nursing institutions, sanitoria, charitable and/or travelling dispensaries, aftercare clinics, maternity homes, children and women welfare centres, orphanages, for old blind, mentally retarded, and handicapped children and persons, widows homes and/or such other similar charitable institutions in all India for the benefit and use of the public general.
