1. Final outcome of Notification to be issued by MoUD, Govt. of India.
2. That the school shall observe the relevant provisions of RTE Act, 2009, DSEAR, -1973 and RTE Act. 2009 and directions/instructions issued by the Department from time to time.
3. That the school shall comply with the orders dated 07/11/2017/ guidelines of DoE and judicial pronouncement w.r.t. safety and security of the students and shall take all necessary steps to the effect.
4. That the school shall comply with the provisions of Section 10(1) read with Rule 125 of DSEAR, 1973.
5. That the school shall comply with clause 14 of order No. F.DE/15(56)/ACT/2009778 dated 11.02.2009 in r/o maintenance of DRF. School also ensure to follow FN.-21 'Accounting by schools' as issued by the Institute of Chartered Accountants of India (ICAI) for proper accounting treatment.
6. That the school shall make payment of salary and other admissible allowances to its teaching/non-teaching staff as per ongoing CPC through banks/RTGS.
7. That the School management shall create a reserve fund in the form of Fixed Deposit (FD) in the joint account in the name of Manager of the School and Deputy Director of Education (South West B-II) equivalent to three months' salary of the staff or Rupees one lakh + Rs 80/- per students, whichever is less in any scheduled bank within three months from the date of issue of letter and copy of FDR is also to be submitted to the concerned district authority.
8. That the school authority shall submit the Police Clearance Certificate (PCC) in r/o all teaching/non-teaching staffs within 03 months to the concerned district authority.
9. That the school shall comply with the order F.No. DE.15 (305)/PSB/ Misc/2020/Pl. File-11/5658-5662 dated 21.06.2023 with regard to appointment of Special Educator.
10. That the school shall comply with the order dated No. F.No.DE15(305)/PSB/Misc/2020/Pl. File-1/5641-5647 dated 20.06.2023 regarding submission of renewed/updated certificates like Fire NOC, Water test report, School Health Certificate, School Building Certificate/Structural stability certificate to the zonal authorities of DoE.
